CORRIGENDUM

In respect of the RFP No. LE/DIPR/04/2022/59, dated 1st August, 2022
Published online on 01/08/2022

The Directorate of Information and Public Relations, Assam has decided to issue the following changes to facilitate proper tendering process in respect of the above mentioned RFP :

1. Clause 6 (under Instructions to Bidders) :

"The Bidder must have minimum 5 years of sound experiences related to production of documentary/film."

Now it will be –

"The Bidder must have minimum 2 years of sound experiences related to production of documentary/docu-feature."

2. Point No 7 of the table in Annexure-A (Technical Bid) :

"Signed and scanned copy of audited Balance sheet of last Three years."

Now it will be –

"Signed and scanned copy of audited Balance sheet of last one year "

3. Clause 4, Point No-9 :

"The bidder should have Average Annual Financial Turnover of minimum 1 crore or more during the last 3 years. Certificate duly signed by a Chartered Accountant to be attached."

Now it will be –

"The Annual Financial Turnover of the bidder should be 1 (one) crore in 2020-21 audited year. Certificate duly signed by a Chartered Accountant to be attached."

4. Clause 4, Point No-10 :

"Signed & scanned copy of Audited Balance sheet, Profit & Loss Account & Auditors Report of last 3 years."

Now it will be –

"Signed & scanned copy of Audited Balance sheet, Profit & Loss Account & Auditors Report of last 1(one) year."

5. Clause 21 :

"Considering the specific involvement of creativity in the work along with implementation; the contract shall be awarded on the basis of Quality and Cost Based Selection (QCBS). Under the QCBS; total evaluation will be of 100 marks; out of which 30% weightage will be given for the Technical Bid and 70% for the Financial Bid."

Now it will be –

"Considering the specific involvement of creativity in the work along with implementation; the contract shall be awarded on the basis of Quality and Cost Based Selection (QCBS). Under the QCBS; total evaluation will be of 100 marks; out of which 70% weightage will be given for the Technical Bid and 30% for the Financial Bid."

6. Clause No 25 (2nd point of the table) :

"Average Annual Turnover during Last 3 Years
Rs. 1 Crore upto Rs. 3 Cr.= 2 marks, Above Rs. 3 Cr. = 5 marks"

Now it will be -

"The annual turnover of 2020-21 should be taken into account which will carry 5 marks."

7. Clause No 25 (3rd point of the table) :

"Experience in similar works for Government/Semi-Govt./PSU in Last 5 Years.
03 to 5 projects = 05 Marks, More than 5 projects = 10 Marks"

Now it will be -

"Experience in similar works for Government/Semi Government/PSUs :
03 to 5 projects = 05 Marks, More than 5 projects = 10 Marks"

8. Clause No 25 (4th point of the table) :

"Length of Relevant Experience"

- 5 to 10 years = 2 marks
- Above 10 years = 5 marks

Now it will be -

"Length of Relevant Experience"

- 2 to 5 years = 2 marks
- Above 5 years = 5 marks
